Through the website [justfundraising.com](http://justfundraising.com), we are interested in selling "America's Variety Pack " chocolate bars and "Gourmet Popcorn."


- The chocolate bars are 50% profit at \$1 per bar, coming in a box of 60. If needed, we would start out with 15 boxes.


